- 2. NIB Card and another valid government is sued ID (**Driver's License**, **Passport or Voter's Card**) of the authorised person pulling the company's report.
  - In the event that you do not have a valid government issued ID we will accept a passport size picture certified by an approved official (Justice of the Peace/Notary Republic, or an Attorney-at-Law.)
- 3. Proof of address ((Recent utility bill or bank statement in your name or Address verification form/letter signed by one of the approved officials listed above).
